**Packaging:** -

**Cut and Re-Mill Products** - vacuum packed in heat sealed bags - Clear Bialon62 VFP film. Thickness 65  $\mu\text{m}$ , weight 62  $\text{g}/\text{m}^2$ , then packed into cardboard boxes and palletised.

**Pre-Pack Products** – Packed in heat sealed White Fincloth Parchment (Thickness 65  $\mu\text{m}$ ), bags with Protective  $\text{CO}_2$  Atmosphere, then packed into cardboard boxes and palletised.

**Metal Detection:** - Finished products are metal detected with designated calibrated test pieces:

Cut - 4.0mm Ferrous, 5.0mm Non-Ferrous and 8.0mm Stainless Steel.

Re-Mill – 3.0mm Ferrous, 3.5mm Non-Ferrous and 5.5mm Stainless Steel.

Pre-Pack – 2.0mm Ferrous, 2.5mm Non-Ferrous and 4.5mm Stainless Steel.
